We begin the Signature Education Series in January 2023 with “Litigation Mitigation,” which will discuss the facility’s risks and best practices to avoid or mitigate undesirable outcomes. Other highlights include preparing for the end of the COVID-19 Public Health Emergency, strategies to prevent rehospitalization, and achieving preferred provider status with referrers. We will focus on survey preparedness and strategies for avoiding negative survey outcomes, as well as responding to Target, Probe, and Educate audits. With staffing as an ongoing nationwide concern, we will explore the use of data and technology to improve staff efficiency, as well as the CMS Minimum Staffing mandates.

With a new Minimum Data Set version becoming effective in October 2023, the impact on Five-Star and QAPI will be discussed, along with the FY 2024 SNF Final Rule. Financial leaders will gain insight into understanding cost centers and applying the information in the facility’s daily operation.

In March of 2020, we never expected to be in a Public Health Emergency (PHE) three years later. While it may not feel that way, the COVID-19 PHE declaration will eventually end, and we will get back to normal, or more appropriately, the new normal. As of now, it is anticipated to continue through April 2023, and time will tell if HHS authorizes another extension. The pre-pandemic qualifying hospital stay requirement will return and will not include observation days. RAC and other audits are a when, not if, and are expected to increase on waiver claims. Readmission to hospitals is also factored into the CMS Five-Star Quality Rating System, which is publicly reported. This presentation will discuss strategies to prevent rehospitalizations pre and post-discharge and avoid financial penalties.
